## Cancellation

You have the right to cancel your policy at any time. If a successful claim has been made against your policy, we may retain your full premium. If you haven't made a claim, we will provide a proportionate refund, based on the number of days you were covered.

If your policy is cancelled more than 14 days after you have received your policy documents, there will be a cancellation fee of £25.00 applied.

You may choose to pay by instalments. If, for example, you decide to cancel a policy or your insurer becomes insolvent, you will still be required to make the agreed repayments. If you do not continue to pay your instalments your insurance may be cancelled.

## Protecting your money

We act as agent for the insurer when collecting and refunding premiums. This means that premiums are treated as being received by the insurer when we receive them. Premium refunds are treated as received by you only when paid to you.
